# 27. Matters arising from the Minutes of Norley Parish Council Meeting of 22/06/16.

- (i) Clerk has asked the support of CWAC Councillor Johnson to meet with Mark Jones Highways to agree a time frame for the Highways work in the village. Clerk instructed to arrange for Councillor O'Connor to meet with Mark as soon as possible.
- (ii) Clerk will complete Equity Housing funding application as soon as she receives quotes for speed indicator devices.
- (iii) Highways have been asked to add Cow Lane to the list of roads in the village that Highways are looking to reduce speed limits on.
